Registrations are open for the selection to enroll in Master's and Doctorate (Ph.D.) courses in the Graduate Program in Physics – PPGF/IF/UFAL (Edital PPGF/CPG-PROPEP/UFAL n.° 01/2023).

A total of 20 vacancies are available, distributed between both levels (Master's and Ph.D.), and for broad competition and reserved quotas. Registration will be conducted exclusively online through the Integrated System of Academic Activities Management - SIGAA from May 12 to June 11, 2023.

Below is a summary of the essential information:

## TARGET PUBLIC

- Candidates with a degree in Physics or related areas who hold a higher education diploma issued by official institutions.
- Candidates who still need to complete the undergraduate course may enroll as long as the completion date is officially set before the start of enrollment in the course.

The selection process comprises:

- I Curriculum Analysis Grade (NAC)
- II School Transcript Grade (NHE)
- III Grade on the Explanatory Memorandum (NEM)

5. Candidates must attach, when registering for the SIGAA SYSTEM (<a href="https://sigaa.sig.ufal.br/sigaa/public/processo\_seletivo/lista.jsf?">https://sigaa.sig.ufal.br/sigaa/public/processo\_seletivo/lista.jsf?</a> nivel=S&aba=p-stricto), only the following documents:

- Completed and signed application form (Annex 1);
  - Personal documents:
    - a) For Brazilians: Identity document, CPF, certificate of performance, or exemption from military service for men between 18 and 45 years old
    - b) For foreigners: National Registry of Foreigners (issued in Brazil, for foreign residents) or Passport;
- Diploma (University Degree) or Certificate of Completion of the Undergraduate Course for enrolling in the Master's, and Undergraduate Diploma and Master's Diploma for enrolling in the Doctorate, issued by the Institution where the title was obtained;
- Master's and/or Undergraduate Academic Transcript (School Records), according to the desired level;
- Curriculum Vitae completed using the LATTES-CNPq form (available on the website http://lattes.cnpq.br/), duly documented with scanned copies of each of the certificates (attach only certificates of activities that generate points for the current selection process, as indicated in the tables of "CRITERIA FOR ANALYSIS OF CURRICULUM" in Annex 2 of this notice). Other resume models will not be accepted.
- Only for candidates competing for quotas: Self-declaration form is needed, duly completed and signed. According to Resolution No. 82/2022-CONSUNI/UFAL, the quilombola (Brazilian afro-descendants) or indigenous candidates must provide documents attesting to their ethnic belonging to that community. These documents must be issued by local leadership, recognized by the Palmares Cultural Foundation or by the National Coordination of Articulation of Rural Black Quilombola Communities (for quilombola) and by indigenous leaders or by the National Indian Foundation FUNAI (for indigenous people). For trans quota holders and/or settlers, a declaration of family income of less than 1.5 minimum wages (one and a half minimum wages) per capita is also required, as well as a declaration of having completed high school in a public school. A settler is a person who lives in an agrarian reform settlement and a group of agricultural units installed by Incra in a rural property. It is necessary to prove this condition of residence. For Disabled Persons (PcD) quota holders, it is also necessary to attach the medical report proving that the person has a long-term physical, mental, intellectual, or sensory impairment (see Article 2 of Brazilian Law No. 13, 146/2015). For quota holders who serve UFAL, attach a paycheck or other official document that proves the effective link with UFAL.
- Only for candidates who will compete for quotas Memorial (descriptive) with at least 2 (two) pages, listing their life trajectory, considering the contribution of this academic education required for their social insertion.
- BAREMA form (Annex 4) completed and signed by the candidate with the intended score, even if it is zero, for each grade in the school records and in the curriculum analysis items that can generate a score in this selection, as per Annex 2 MANDATORY FOR ALL CANDIDATES.
- Syllabuses (course programs) of subjects considered equivalent (stamped and signed by the course coordinator or digitally certified) that the candidate who wants the selection committee to consider as equivalent to those mentioned in the evaluation criteria of the school record in Annex 2 of the public notice attach only if necessary.
  - § 1 The diploma or certificate of completion of the course may be replaced by a declaration, issued by a higher education institution, that the student has completed the course solely for enrollment in the current selection process. For the act of registration, it will be mandatory to present the diploma; or, if this has not yet been issued, a document proving undergraduate completion will be accepted provisionally (where it appears that the student has already obtained a degree, and the date of graduation) or a master's degree (with a copy of the master's dissertation defense minutes attached); Course completion certificates are only valid for a period recognized by UFAL for six months from the date of issue, after which a copy of the diploma must be presented.
